Voting Accessibility for Elderly and Handicapped Electors

In its efforts to assure that any handicapped or elderly voter assigned to an inaccessible polling place is provided with an alternative means of casting a ballot on the day of election, Union County Board of Election has designated the Union County Government Center as an alternative voting place for such persons. Some polling places located in Union County may be inaccessible to some electors due to architectural barriers. Any handicapped or elderly elector who feels that this may be the case in their assigned polling place is urged to contact the Union County Board of Election to learn the procedure for applying for an ‘Alternative Ballot’. The Union County Board of Election must receive the application for an ‘Alternative Ballot’ no later than Tuesday, October 26, 2021 by 5:00 P.M. The Union County Board of Elections may consider Emergency Alternative applications until 5:00 P.M., Friday, October 26, 2021.

Electors who are provided with an ‘Alternative Ballot’ and who chose to wait until Election Day to cast their ballots must return their own ballot to the Union County Government Center, 155 N. 15th St., Lewisburg, PA, up to the time the polls close at 8:00 P.M., November 2, 2021.
